GRI SCHOLARSHIP

In Memory of Jerie Pickering

- Background: Jerie Pickering was owner/broker of CANNON REALTY, President of the Skagit County Board of REALTORS® in 1970, W.R REALTOR® of the year in 1980, and for years an active driving force in all phases of the local and State Association of REALTORS®. She was a devoted advocate of REALTOR® Education and, particularly, the Graduate REALTOR® Institute (GRI). On January 9, 1986, the Skagit County Board of REALTORS® established the GRI Scholarship Fund in her memory.
- Policy: The GRI Scholarship Fund is sponsored by the North Puget Sound Association of REALTORS® to assist deserving REALTORS® participate in GRI by contributing towards member(s) tuition for GRI 100, 200 and 300. It is intended that such assistance will inspire the members to complete the GRI series, leading to a professional designation sanctioned by the National Association of REALTORS®.
- Funding: This Scholarship shall be a regular budget item subject to review by the Budget & Finance Committee and approval of the Board of Directors.
- Administration: The NPSAR Education Committee, under the direction and subject to the approval of the Board of Directors, shall be responsible for the overall administration of the Scholarship award. They shall, from time to time, promulgate information and availability of funds concerning the scholarship. They shall solicit and review all applications and present their recommendations to the North Puget Sound Association of REALTORS® for approval. Once approved, the Executive Officer shall prepare a check to Washington REALTORS® in the amount approved for presentation to the recipients at the Installation and Awards Banquet held in December or January of each year.
- Eligibility Requirements To be eligible for application members must:
- A) Be a licensed REALTOR® in good standing and a member of the National Association of REALTORS® and the North Puget Sound Association of REALTORS®.
 - B) Be a full-time REALTOR® as substantiated by your broker.
- Application Applications may be obtained at the North Puget Sound Association of REALTORS® office.
- Procedure Applications, once completed, should be submitted to the association office *on or before November 15th* for review by the Education Committee.
